TAX BILLS MAILED IN JUNE AND DUE AUG 1 AND NOV 1, 2004 WERE THE ESTIMATED QUARTERLY BILLS FOR FY 2005. ACTUAL REAL ESTATE BILLS WITH NEW ASSESSMENTS AND TAX AMOUNTS WILL BE MAILED IN MID DECEMBER AND DUE FEB. 1 AND MAY 1, 2005.
