Please take notice that the Board of Selectmen of the Town of Reading will hold a public hearing on Tuesday, August 9, 2005, at 7:45 p.m. in the Selectmen's Meeting Room, 16 Lowell Street, Reading, Massachusetts on the following proposed traffic rules and regulations:

Stop intersection as follows: Zachary Lane at Dividence Road; Collins Avenue at Franklin Street; Chapel Hill Drive at Franklin Street; Terrace Park at Franklin Street; Kurchian Lane at Franklin Street; Emerson Road at Franklin Street; Fox Run Lane at Franklin Street; Buckskin Drive at Franklin Street; Blueberry Lane at Franklin Street; Sunset Rock Lane at Franklin Street; William Road at Franklin Street; Pasture Road at Franklin Street; Susan Drive at Franklin Street; Van Norden Road at Franklin Street; Covey Hill Road at Franklin Street; Meadowbrook Lane at Franklin Street; Larch Lane at Franklin.

No stopping, standing or parking both sides of Franklin Street 500 feet in both directions from Sunset Rock Lane.

No stopping, standing or parking 7:30 a.m. to 8:30 a.m. and 2:30 p.m. to 3:30 p.m., Monday through Friday, September 1 through June 30: both sides of Dividence Road from Zachary Lane westerly to the end of Dividence Road; the east side of Emerson Street for its entire length; the west side of Fox Run Lane for its entire length.

Do not enter 7:30 a.m. to 8:30 a.m. and 2:30 p.m. to 3:30 p.m. Monday through Friday, September 1 through June 30 (emergency vehicles exempt) Emerson Road at Franklin Street.

Do not enter (except for residents) 7:30 a.m. to 8:30 a.m. and 2:30 p.m. to 3:30 p.m. Monday through Friday, September 1 through June 30 (emergency vehicles exempt).

Reconsider parking restrictions on the west side of Sunset Rock Lane and on the west side of Roma Lane to read as follows: No stopping, standing or parking 7:30 a.m. to 8:30 a.m. and 2:30 p.m. to 3:30 p.m. Monday through Friday, September 1 through June 30.
